### THE PURPOSE OF LEGAL CLINICS

- To enable students to develop problem-solving and decision-making skills
- To provide practical experience through working on real legal cases or real-life environmental issues
- To develop ethical skills and judgment through engagement with "social justice" issues
- To contribute to the advancement of advocacy (legal/political) within a particular social and legal context

## Activities undertaken in a Legal Clinic



- Preparation of sworn statements or affidavits
- Writing letters or submissions on behalf of clients on legal or policy issues
- Drafting written arguments for submission to court



# SUN ACADEMA OF

### ACTIVITIES UNDERTAKEN IN A LEGAL CLINIC

- Representing clients in public hearings or court proceedings
- All such activities are undertaken under the close supervision of a teacher/mentor (usually an experienced lawyer)
- Can involve **placement** of students in a legal aid office, law firm, justice institution or NGO
- Many environmental law clinics (especially in USA) operate from within a Law School





### MODELS FOR ENVIRONMENTAL LAW CLINICS IN USA

- Law firm model clinic has its own clients
- Co-counsel model clinic is in partnership with a public interest law firm that provides clients
- In-house counsel model clinic is situated within an environmental NGO (e.g., Earth Justice of National Wildlife Federation)
- Think tank model clinic conducts research, scholarship and community/professional education (e.g., through conferences)

## Law Internships in the Philippines

- Summer law interns are assigned with public interest law groups
- Law interns undergo a basic orientation seminar and immersion
- Some law interns who become lawyers work with public interest environmental law groups

### ESTABLISHMENT OF ENVIRONMENTAL LAW CLINICS WORLD-WIDE

- Survey conducted in 2012 for IUCN Academy of Environmental Law by Professor Maria Marquès i Banqué from Universitat Rovira i Virgili, Tarragona, Spain:
  - 44 in USA (including in all of the top 18 environmental law programmes)
  - 5 in Latin America (3 in Argentina, 1 each in Chile and Colombia)
  - 3 in Europe (2 in Spain, 1 in Netherlands)
  - 3 in Canada
  - 1 each in Australia, China, India and Israel.
