**PART I**

**PRELIMINARY**

1. These Regulations may be cited as the Fisheries Regulations.

**PART II**

**REGULATION OF FISHING**

2. No person shall, except under the terms and conditions of a valid licence or where the fish captured or killed are intended solely for the consumption by the fisherman and his household and where none such fish are sold, in Brunei Darussalam waters —

Restrictions  
on fishing.

(a) erect, maintain, use or operate any kilong;

(b) use for the purpose of catching or killing fish any kind of other fishing appliance.

3. No person shall, except under the terms and conditions of a valid licence —

Restriction of  
import, etc.

(a) import into or export from Brunei Darussalam or have in transit in Brunei Darussalam any fish whether live or dead;

(b) act as a fish dealer;

(c) use or operate from Brunei Darussalam any kilong or other fishing appliance.

4. No person shall import, offer for sale, be in possession of or use any spear gun.

5. Any Licensing Officer may, subject to the provisions of the Fisheries Act, issue to any person on such terms and conditions as he may specify, a licence for —

(b) any other fishing appliance;

Fees.                    6. The fees specified in the Schedule hereto shall be payable in the respect of licences and renewal of licences.

7. Any fisherman and any fish dealer shall, to the best of his knowledge and belief, answer when so required, all questions asked of him by an Authorised Officer which are necessary to the obtaining of any information required for the compilation of statistics in relation to the fishing industry.

**LICENCE FEES**

**1. Traps:**

(a)	Kilong (Deep water fish trap made of stakes, poles or other supports with leaders so designed as to lead fish into an enclosure, and the length of such leaders exceeding 60 fathoms .....	\$ 8.00
(b)	Lintau (Shallow water fish trap made of stakes, poles or other supports with leader or leaders so designed as to lead fish into an enclosure, and the length of such leader or leaders not exceeding 60 fathoms .....	\$ 4.00
(c)	Bubu Any other type of fish trap longer than 3 feet .....	\$ 0.40
(d)	Kabat Any fish trap made of leader or leaders leading into a trap net.	
	Less than 5 yards in length .....	No Fee
	More than 5 yards in length .....	\$ 4.00
(e)	Tugu per net .....	\$ 4.00

**2. Nets:**

(a)	Anchau, Paguyut: Any seine net with pocket and any seine net without pocket not —	
	exceeding 40 yards in length .....	\$ 1.00
	exceeding 40 yards in length .....	\$ 4.00
(b)	Tabeh, Pukat: Any seine net without pocket not exceeding 40 yards in length .....	\$ 1.00
	exceeding 40 yards in length .....	\$ 1.00
	more than 40 yards in length .....	\$ 4.00
(c)	Andang, Tambak, Panau: Any bottom set gill net. Per 200 yards mounted length or part thereof .....	\$ 4.00
(d)	Rantau, Slambau: Drifting and lifting gill nets. Per 100 yards mounted length or part thereof .....	\$ 2.00

(e)	Lukong: Any ring net or purse seine. Per 100 yards mounted length or part thereof .....	\$ 30.00
(f)	Panau: Any scoop net .....	\$ 2.00

(h)	Pukat Rimau: Any trawl net including otter, beam, floating or midwater trawl and any other net used for sea fishing and not specified above .....	\$200.00
3. Lines and Hooks:		
	Gurit: Long line with more than 2 hooks, per hook .....	\$ 0.25
4.	Explosives and Poisons .....	No Fee
5.	Disposal of fish in Brunei Darussalam .....	\$ 10.00
6.	Import, Transit and Export of fish .....	\$ 20.00
