THE AMENDMENT OF THE DECREE OF THE MINISTER OF AGRICULTURE NO. 144/KPTS/IK.410/2/1993

THE MINISTER OF AGRICULTURE,

Considering

:

- a. that in the framework of control over the implementation of the utilization of fish resources the Decree of the Minister of Agriculture No. 144/KPTS/IK.410/2/1993 has fixed seaports as bases for fishing ships with foreign flags hired by Indonesian fishery companies to catch fish in Indonesia's Exclusive Economic Zone:
- b. that with the wider use of fishing ships with foreign flags by Indonesian fishery companies and at the same time with a view to increasing exports of fishery produce, it is necessary to intensify control by means of increasing the number of seaports as bases for fishing ships with foreign flags;
- that on the basis of the above-mentioned matters, it is deemed necessary to amend Article 1 of the Decree of the Minister of Agriculture No. 1/Kpts/IK.410/2/1993;

HAS DECIDED:

To stipulate: THE AMENDMENT OF THE DECREE OF THE MINISTER OF AGRICULTURE NO. 144/KPTS/IK.410/2/1993.

Article I

To amend Article 1 of the Decree of the Minister of Agriculture No. 144/Kpts/JK.410/2/1993 by supplementing 2 (two) Ports as Bases for fishing ships with foreign flags hired by Indonesian fishery companies so that it shall read as follows:

Article 1

The ports fixed as bases for fishing ships with foreign flags hired by Indonesian fishery companies to cable fish in Indonesia's Exclusive Economic Zone prior to and after catching fish, which shall hereinafter be referred to as base ports, shall be as follows:

- A. For those whose fishing area lie in Indonesia's Exclusive Economic Zone of the South China Sea and the Pacific Ocean the base ports are:
 - 1. General Port of Tanjung Pinang in Riau Province;
 - 2. Fishery Port of Terempa in Riau Province:
 - 3. General Port of Batam in Riau Province;
 - 4. Fishery Port of Tarakan in East Kalimantan Province;
 - 5. General Port of Nunukan in East Kalimantan Province;

- 6. Fish Disembarkation Base of Sebatik in East Kalimantan Province;
- 7. Bitung Fishery Port of North/Central Sulawesi Fishery Limited Liability Company in North Sulawesi Province;
- 8. Fishery Port of Daghoo in North Sulawesi Province;
- 9. Fishery Port of Sorong in Irian Jaya Province;
- 10. General Port of Biak in Irian Jaya Province.
- B. For those whose fishing areas lie in Indonesia's Exclusive Economic Zone of the Sulawesi Sea the base ports are :
 - 1. Fishery Port of Tarakan in East Kalimantan Province;
 - 2. General Port of Nunukan in East Kalimantan Province:
 - 3. Fish Disembarkation Base of Sebatik in East Kalimantan.
- C. For those whose fishing areas lie in Indonesi's Economic Zone of the Indian Ocean and the Arafura Sea the base ports are :
 - 1. Sabang Fishery Port of Samudera Besar Fishery Limited Liability Company in the Special Region of Aceh;
 - 2. General Port of Sibolga in North Sumatera Province;
 - 3. Fishery Port of Tello Island in North Sumatera Province;
 - 4. Fishery Port of Bungus in West Sumatera Province;
 - 5. General Port of Baai Island in Bengkulu Province;
 - 6. Fishery Port of Pelabuhan Ratu in West Java Province;
 - 7. Ocean Fishery Port of Jakarta in the Special Region of Capital City of Jakarta;
 - 8. General Port of Cilacap in Central Java Province;
 - 9. General Port of Benoa in Bali Province;
 - 10. Fishery of Kupang in East Nusa Tenggara Province;
 - 11. General Port of Com in East Timor Province;
 - 12. General Port of Ambon in Maluku Province;
 - 13. Ambon Fishery Port of Public Corporation of Maluku Fishery in Maluku Province.
- D. For those whose fishing areas lie in Indonesia's Exclusive Economic Zone of the Indian Ocean the base port is Nusantara Fishery Port of Belawan in North Sumatera Province;
- E. For those fishing areas lie in Indonesia's Exclusive Economic Zone of the Arafura Sea the base port is the Fish Disembarkation Base of Ternate in Maluku Province.

Article II

This decree shall take effect as from the date of stipulation.
