GENERAL GUIDE TO THE MANAGEMENT OF COMPOUND NPK FERTILIZER, GRANULATED ORGANIC FERTILIZER AND LIQUID ORGANIC FERTILIZE DIRECT ASSISTANCE OF THE BUDGET YEAR 2011

(Regulation of the Agriculture Minister No. 73/Permentan/ SR.130/10/2011 dated October 31, 2011)

BY THE GRACE OF GOD ALMIGHTY
THE AGRICULTURE MINISTER.

Considering:

- a. that pursuant to Article 5 of Presidential Regulation No. 14/2011 on Superior Seed and Fertilizer Direct Assistance, the Agriculture Minister is mandated to stipulate General Guide to the Management of Fertilizer Direct Assistance;
- b. that through the use of budget austerity at the Agriculture Ministry in 2011, there has been extra budget and aid package fees for compound NPK fertilizer, granulated organic fertilizer and liquid organic fertilizer direct assistance of the budget year 2011;
- the efficiency and effectiveness of fertilizer direct assistance, it is necessary to stipulate General Guide to the Management of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance of the Budget Year 2011;

DECIDES:

To stipulate:

REGULATION OF THE AGRICULTURE MINISTER ON GENERAL GUIDE TO THE MANAGEMENT OF COMPOUND NPK FERTILIZER, GRANULATED ORGANIC FERTILIZER, AND LIQUID ORGANIC FERTILIZER DIRECT ASSISTANCE OF THE BUDGET YEAR 2011.

Article 1

The General Guide to the Management of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance of the Budget Year 2011 is contained in the attachment which is an integral part of this Regulation.

Article 2

The General Guide to the Management of Fertilizer Direct Assistance as referred to in Article 1 is intended to lay a basis for the realization of fertilizer direct assistance of the budget year 2011 for central and regional apparatuses to ensure that the effort to increase food security can run effectively, efficiently, transparently and accountably.

Article 3

The provision and distribution of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance of the Budget Year 2011 is done by assigning state-owned companies.

Article 4

- (1) The distribution of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance to farmer groups is done based on proposals from Prospective Farmers and Location (CPCL).
- (2) CPCL as referred to in paragraph (1) is decided by governor by paying attention to suggestions and considerations from regents/mayors.
- (3) In deciding CPCL as referred to in paragraph (2) the Governor can delegate the task to the Head of the Provincial Agriculture Office.
- (4) In giving suggestions and considerations as referred to in paragraph (2) the Regent can delegate the task to the Head of the Regency/Municipal Agriculture Office.
- (5) The Director General of Agricultural Infrastructures and Facilities on behalf of the Agriculture Minister decides allocations of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer direct assistance for each region through a decree of the Agriculture Minister.

Article 5

- (1) To ensure the realization of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance of the Budget Year 2011 as referred to in Article 1, the Director General of Agricultural Infrastructures and Facilities shall act as technical patron.
- (2) In carrying out tasks, the Director General of Agricultural Infrastructures and Facilities in the capacity as technical patron as referred to in paragraph (1) can issue Guide to the Management of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance of the Budget Year 2011.

Article 6

To ensure the smooth realization of Compound NPK Fertilizer, Granulated Organic Fertilizer and Liquid Organic Fertilizer Direct Assistance of the Budget Year 2011 there must be supervision from the Directorate General of Agricultural Infrastructures and Facilities, the Inspectorate General, and the Finance and Development Supervisory Board (BPKP).

Article 7

This Regulation shall begin to take effect as from the date of stipulation.
