THE AGRICULTURE MINISTER.

- b. that to provide certification service as referred to in letter a, Decree of the Agriculture Minister No. 550/Kpts/OT.140/9/2004 on Agricultural Product Certification Institution and Regulation of the Agriculture Minister No. 39/Permentan/ OT.140/8/2008 on the Formation of Agricultural Tool and Machinery Certification Institution have been stipulated;
- c. that in line with a change in the organizational structure and work mechanism of the Agriculture Ministry, it is necessary to review the policy as referred to in letter b by stipulating a Regulation of the Agriculture Minister;

DECIDES:

To stipulate:

REGULATION OF THE AGRICULTURE MINISTER ON AGRICULTURAL PRODUCTS CERTIFICATION INSTITUTION.

Article 1

Agricultural Products Certification Institution, hereinafter called LS-Pro, is formed as a non-structural institution at the Agriculture Ministry.

Article 2

LS-Pro as referred to in Article 1 shall consist

of:

 LS-Pro for Agricultural Tools and Machines, with the scope of agricultural tools and machines,

based at the Center for the Quality Test of Agricultural Tools and Machines, Directorate General of Agricultural Products Processing and Marketing.

- 2. LS-Pro for Food Crop and Horticultural Seed and Seedling, with the scope of food crop and horticultural products, based at the Center for the Development of Quality Test of Food Crop and Horticultural Seeds (PPMB-TPH Center), Directorate General of Food Crops.
- LS-Pro for Germ and Young Cattle, with the scope of germ and young cattle product, based at the Directorate General of Husbandry and Animal Health.

Article 3

LS-Pro as referred to in Article 2 are assigned to certify agricultural products and issue Certificates of Products Using Indonesian National Standard (SPPT SNI).

Article 4

In performing the duties as referred to in Article 3, LS-Pro are responsible and convey reports to the Agriculture Minister through the Director Generals at the Agriculture Ministry according to their authority.

Article 5

Further provisions on the procedure and realization of certification are stipulated by the Director Generals at the Agriculture Ministry according to their authority.

Article 6

LG-Pro as referred to in Article 2 shall have been accredited by the National Accreditation Committee of the National Standardization Board no later than 2 (two) years after this Ministerial Regulation has been promulgated.

Article 7

The operational costs of LS-Pro shall be borne by the budget of respective Directorate General at the Agriculture Ministry.

Article 8

With the promulgation of this Ministerial Regulation;

- Decree of the Agriculture Minister No. 550/Kpts/ OT.140/9/2004 on Agricultural Products Certification Institution; and
- Regulation of the Agriculture Minister No. 39/ Permentan/OT.140/8/2008 on the Formation of Agricultural Tool and Machine Certification Institution;

shall be revoked and declared null and void.

Article 9

This Ministerial Regulation shall come into force as from the date of promulgation.

For public cognizance, this Ministerial Regulation shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
