# Considering:

- a. that in order to achieve four targets of agricultural development success, it requires agricultural area extension, provision of infrastructure and facilities for water and land management, provision of government food reserve, provision of infrastructure and facilities of Seed/Cultivation Agency, Agricultural Extension Service, Center/Clinic/Post of Animal Health Service and Artificial Insemination as well as adequate post-harvest handling in region;
- that in order to help regency/municipal government in physical provision of agricultural infrastructure and facilities, central government needs to allocate Special Allocation Fund for Agriculture 2012;
- c. that based on the aforementioned things and to follow up Article 59 paragraph (1) Government

  Regulation Number 55/2005 concerning Ballance Fund, it is considered necessary to stipulate Technical Guidelines for Utilization of Special Allocation Fund for Agriculture, 2012;

REGULATION OF MINISTER OF AGRICULTURE CON-CERNING TECHNICAL GUIDELINES FOR UTILIZA-TION OF SPECIAL ALLOCATION FUND FOR AGRI-CULTURE, 2012

#### Article 1

Technical Guidelines for Utilization of Special Allocation Fund for Agriculture, 2012 as stated in Attachment as inseparable part of this Regulation.

#### Article 2

Technical Guidelines for Special Allocation Fund Utilization for Agriculture, 2012 is meant as reference for regency/municipal government in utilization of Allocation Fund for Agriculture, 2012.

Article 3

# GOVERNMENT REGULATIONS

Allocation Fund for Agriculture, 2012 is used for main activities and supporting activities. Main activities are: (1) extension of agricultural areal; (2) provision of water management infrastructure and facilities; (3) provision of land management infrastructure and facilities; whereas supporting activities are: (1) Provision of government food reserve storehouse; (2) Construction/rehabilitation/renovation of Agricultural Extension Service in Sub-District and Provision of extension facilities; (3) Provision of infrastructure and facilities of regency/municipal Seed/Cultivation Agency for crop, horticulture, plantation and animal husbandry; (4) Construction/rehabilitation of Center/Clinic/Post of Animal Health Service and Artificial Incemination; and (5) Post-harvest handling.

# Article 4

Activities of Special Allocation Fund for Agriculture, 2012 as meant in Article 3 are optional activities, so that region can choose one or several activities in accordance to priority and policy of region as well as the availability of budget ceiling.

#### Article 5

The amount of budget ceiling of regency/municipal Special Allocation Fund for Agriculture, 2012 of every region is in accordance to decision of Minister of Finance.

#### Article 6

The responsibility and management of activities of Special Allocation Fund for Agriculture are handled by Regional Working Unit namely Department/Agency/Office of district/city in the field of crop, horticulture, animal husbandry, food security, extension, and/or other names in district/city respectively to their authorities, duties, and functions.

#### Article 7

Activities other than activities as meant in Article 3 cannot be funded from Special Allocation Fund for Agriculture, 2012.

#### Article 8

This Regulation starts to take effect since the stipulation date.
