

QUARANTINE PLANT PATHOGENIC ORGANISM

(The Regulation of Minister of Agriculture of RI Number 93/Permentan/OT.140/12/2011, 29 December 2011)

BY THE GRACE OF ONE AND ALMIGHTY GOD
THE MINISTER OF AGRICULTURE,

Considering:

- a. that by Decree of Minister of Agriculture Number 38/Kpts/HK.060/I/2006, it has been decided Types of Quarantine Plant Pathogenic Organisms Group 1 Category A1 and A2, Group II Category A1 and A2, Host Plant, Carrier Media, and Dissemination Area;
- b. that based on result of risk analysis and result of monitoring on plant pathogenic organisms, there is status change of types of quarantine plant pathogenic organisms.
- c. that based on consideration as meant in point a and point b, it is necessary to re-regulate types of quarantine plant pathogenic organisms with Regulation of Minister of Agriculture.

DECIDED :

To stipulate:

REGULATION OF MINISTER OF AGRICULTURE CONCERNING TYPES OF QUARANTINE PLANT PATHOGENIC ORGANISMS.

Article 1

(1) Based on their existence, quarantine plant pathogenic organisms are categorized into quarantine plant pathogenic organisms category A1 and quarantine plant pathogenic organisms category A2.

(2) Quarantine plant pathogenic organisms category A1 are quarantine plant pathogenic organisms that are not found in Indonesia.

(3) Quarantine plant pathogenic organisms category A2 are quarantine plant pathogenic organisms that are already found in Indonesia, but still limited and being controlled.

Article 2

(1) Based on plant quarantine action result through

treatment, quarantine plant pathogenic organisms are classified into quarantine plant pathogenic organisms group I and quarantine plant pathogenic organisms group II.

(2) Quarantine plant pathogenic organisms group I as meant at paragraph (1) are quarantine plant pathogenic organisms that cannot be freed from carrier media of quarantine plant pathogenic organisms

(3) Quarantine plant pathogenic organisms group II as meant at paragraph (1) are quarantine plant pathogenic organisms that can be freed from carrier media of quarantine plant pathogenic organisms.

Article 3

Types of quarantine plant pathogenic organisms as meant in Article 1 and group of quarantine plant pathogenic organisms as meant in Article 2, as stated in the Attachment as inseparable part of this Minister Regulation.

Article 4

Hereby the promulgation of this Minister Regulation, Decree of Minister of Agriculture Number 38/Kpts/HK.060/I/2006, concerning Types of Quarantine Plant Pathogenic Organisms Group 1 Category A1 and A2, Group II Category A1 and A2, Host Plant, Carrier Media, and Dissemination Area, is revoked and declared null and void.

Article 5

This Minister Regulation starts to take effect since the promulgation date.

For everybody to acknowledge this regulation, this Minister Regulation is promulgated by placing it in the State Gazette of the Republic of Indonesia.
