PROCEDURE FOR DETERMINATION OF FOREST PRODUCT BENCHMARK PRICE FOR CALCULATION OF RESOURCES ROYALTY PROVISION

THE REPUBLIC OF INDONESIA,

Considering:

Article 9 of Government Regulation Number 51/1998 concerning Resources Royalty Provision, and Article 3 Government Regulation Number 59/1998 concerning Service Tariff Of Non-Tax State Revenue Valid At Department of Forestry and Plantation as has been amended for several times, the last one with Government Regulation Number 92/1999, it is necessary to stipulate Regulation of Minister of Trade concerning Procedure for Determination on Forest Product Benchmark Price For Calculation of Forest Resource Provision;

To stipulate:

REGULATION OF MINISTER OF TRADE CONCERN-ING PROCEDURE FOR DETERMINATION OF FOREST PRODUCT BENCHMARK PRICE FOR CALCULATION OF RESOURCES ROYALTY PROVISON.

Article 1

In this Minister Regulation there are definitions as follows:

- ated as PSDH is collection imposed on as substitute for intrinsic value and product collected from state forest.
- 2. Minister is the minister who organizes governmental affairs in trade field.

Article 2

- (1) Forest Product Benchmark Price hereafter mentioned as Benchmark Price is amount of value or price of forest produce in rupiah as calculation base for PSDH.
- (2) Benchmark Price as meant at paragraph (1) is stipulated periodically by Minister by referring to forest product weighted average selling price effective in domestic and/or overseas market.
- (3) Types of forest product on which Benchmark Price decided upon are stated in Attachment as inseparable part of this Minister Regulation.

Article 3

- (1) Forest product weighted average selling price as meant in Article 2 paragraph (2) is obtained based on result of survey on market price performed by independent surveyor.
- (2) Cost of the conduct of survey as meant at paragraph (1) is funded from State Budget.

Article 4

In case the new Benchmark Price has not yet been decided, the previous Benchmark Price, which validation has ended, is stated as still in effect.

Article 5

This Minister Regulation starts to take effect since the stipulation date.

For everybody to acknowledge this regulation, ordering the promulgation of this Minister Regulation to be placed in the State Gazette of Republic of Indonesia.
