In view of:

Considering:

- a. in the framework of implementation of national priority concerning counter measuring poverty through Marine Affairs and Fishery Independent Society Empowerment National Program Activity, it needs to be supported with policies in order to reach the improvement of business competency and welfare, development of marine affairs and fishery entrepreneurship as well as the improvement of environmental quality.
- b. in the framework of effectiveness of the implementation of Marine Affairs and Fishery Independent Society Empowerment National Program, it is necessary to arrange Implementing Guidelines for Marine Affairs and Fishery Independent Society Empowerment National Program;

REGULATION OF MINISTER OF MARINE AFFAIRS AND FISHERY CONCERNING IMPLEMENTING GUIDELINES FOR MARINE AFFAIRS AND FISHERY INDEPENDENT SOCIETY EMPOWERMENT NATIONAL PROGRAM 2012.

Article 1

Implementing Guidelines for Marine Affairs and Fishery Independent Society Empowerment National Program is intended as implementing guidelines for Rural Fishery Business Development (PUMP), People Salt Business Empowerment (PUGAR), and Solid Coastal Villages Development (PDPT).

Article 2

Provision concerning Implementing Guidelines for Marine Affairs and Fishery Independent Society

Empowerment National Program as stated in the attachment as inseparable part of this Minister Regulation.

Article 3

Implementation details of Marine Affairs and Fishery Independent Society Empowerment National Program is stipulated in technical guidelines by the Director General related to the Ministry of Marine Affairs and Fishery by referring to this Minister Regulation and the implementation is reported in written to the Minister through Secretary General.

Article 4

This Minister Regulation starts to take effect since the promulgation date.
