

## CHANGE OF NAMES OF FORMULAS AND USE OF PESTICIDES

(Decree of the Minister of Agriculture No. 405/Kpts/SR.140/6/2004 dated June 14, 2004)

MINISTER OF AGRICULTURE,

Considering:

- a. that, in Decree of the Minister of Agriculture on registration and grant of license of pesticide, names and dosage for the application of each pesticide formula are also contained;
- b. that, some owners of pesticide formulas have submitted request to change names of formulas and use of pesticides;
- c. that, based on the matter as mentioned above, it is necessary to change names of formulas and use of pesticides.

**DECIDES :**

To stipulate:

**DECREE OF THE MINISTER OF AGRICULTURE ON CHANGE OF NAMES OF FORMULAS AND USE OF PESTICIDES**

**Article 1**

Changing names of formulas and dosage of pesticides as described in column 2 to become those as described in column 3 in Appendices I and II to this Decree.

**Article 2**

Pesticide license holders as specified in column 4 in Appendices I and II to this Decree are granted license to distribute and issue certification of pesticides of their responsibility as set forth in Article 1 of Decrees of the Minister of Agriculture No. 251/Kpts/TP.120/5/2001; No. 480/Kpts/TP.270/8/2002; No. 482/Kpts/TP.270/8/2002; No. 294/Kpts/TP.270/5/2003; No. 442/Kpts/SR.140/9/2003; and No. 45/Kpts/TP.270/1/2003 (BN No. 6929 p. 1A-3A).

**Article 3**

Pesticides with old names as described in Article 1 shall not be imported and or manufactured locally.

**Article 4**

The pesticides with old names as described in Article 1, which have entered into the Indonesian territory, shall only be distributed and used in accordance with the applicable regulations, within no more than 1 (one) year from the stipulation of this Decree.

**Article 5**

If those pesticides with old names as described in Article 1, within the period, as meant in Article 4, have not been used up, they must be exited from the Indonesian territory or must be destroyed by the owners or the controlling parties in accordance with the applicable regulations.

**Article 6**

This Decree shall come into effect from the date of stipulation.
