REGULATION OF THE MINISTER OF FORESTRY REGARD-ING THE AMENDMENT TO REGULATION OF THE MINISTER OF FORESTRY NUMBER P,54/MENHUT-II/2007 REGARDING EQUIPMENT PERMIT FOR ACTIVITY OF BUSINESS PERMIT OF THE ADVANTAGE ON WOOD FOREST PRODUCTION AT NATURAL FOREST OR ACTIVITY OF WOOD ADVANTAGE PERMIT OR AUCTION RESULT.

Article I

Provision in Regulation of the Minister of Forestry Number P.54/Menhut-II/207 regarding Equipment Permit for the Activity of Business Permit on the Advantage of Wood Natural Production (IUPHHHK) at Natural Forest or Activity of Wood Advantage Permit (IPK) or Auction Result changed as follow:

Added 1 (one) new article between Article 13 with Article 14, was Article 13A that was mentioned as follow:

Article 13A

- (1) Entrance permit and equipment usage for IPK activity at natural forest by leasehold is published by the Director of Development of Natural Forest on behalf of the Director General of Forestry Production Development:
- (2) The Application requirement as referred at sentence1, is as follow:
 - a. copy of the Decision of the Minister regarding Leasehold of Forest Area;
 - b. explanation on tool originality is proven by purchasing invoice of equipment if the equipment belongs to himself or proof of explanation letter of rent or borrow if the equipment was not belong to himself:
 - c. technical consideration from Head of Province Department, which is filled the tool type, tool amount, tool specification (chasis number, machine number, manufactured year), and calculation result for the necessity of equipment optimal; and

- d. submit AMDAL or UKL and UPL on the activity at the area that was IPK according with the effective provision.
- (3) The Application as referred at sentence 1 was proposed to the Director General of Forestry Production Development through the Director of Natural Forest Development, with carbon copy made available to:
 - a. Head of Province Department;
 - b. Head of Sub-District/Town Department;
 - c. Head of Monitoring Hall on the Production Forest Advantage.
- (4) The Director evaluates the fulfillment of application requirement as referred at sentence 2.
- (5) In case the application not fulfilling the requirement, the Director returns the application to be completed its requirement.
- (6) In case the application fulfilling the requirement, the Director on behalf of the Director General issues the Entrance Permit and Equipment Usage for time period 20 (twenty) working days since the accepted of application.

Article II

- (1) Provisions in the Regulation of the Minister of Forestry Number P.54/Menhut-II/2007 regarding Equipment Permit for the Activity of Business Permit on the Advantage of Wood Natural Production (IUPHHHK) at Natural Forest or Activity of Wood Advantage Permit (IPK) or Auction Results stated still effective as long as did not change with this Regulation.
- (2) This Regulation shall take effect since the stipulated date.
