

THE SECOND ROUND OF AMENDMENT TO REGULATION OF THE FORESTRY MINISTER NO. P.45/MENHUT-II/2007 ON THE PROCEDURE OF LICENCING EQUIPMENT USED IN THE EXPLOITATION OF WOOD FORESTRY PRODUCTS FROM TIMBER ESTATES IN PLANTATION FORESTS

(Regulation of the Forestry Minister No.7/Menhut-II/2008 dated March 14, 2008)

THE FORESTRY MINISTER,

Considering:

- a. that based on Regulation of the Forestry Minister No.P.45/Menhut-II/2007 adj. No. P.02/Menhut-II/2008, the Procedure of Licencing Equipment Used in the Exploitation of Wood Forestry Products from Timber Estates in Plantation Forests has been set;
- b. that to implement the Regulation of the Forestry Minister as referred to in letter a, several provisions in the regulation still need to be improved;
- c. that in conjunction with the above matters, it is necessary to stipulate the Second Round of Amendment to Regulation of the Forestry Minister No. P.45/Menhut-II/2007 adj. No. P.02/Menhut-II/2008 on the Procedure of Licencing Equipment Used in the Exploitation of Wood Forestry Products from Timber Estates in Plantation Forests by issuing a Regulation of the Forestry Minister;

DECIDES :

To stipulate:

REGULATION OF THE FORESTRY MINISTER ON THE SECOND ROUND OF AMENDMENT TO REGULATION OF THE FORESTRY MINISTER NO. P.45/MENHUT-II/2007 ON THE PROCEDURE OF LICENCING EQUIPMENT USED IN THE EXPLOITATION OF WOOD FORESTRY PRODUCTS FROM TIMBER ESTATES IN PLANTATION FORESTS.

Article I

Provisions in Regulation of the Forestry Minister No. P.45/Menhut-II/2007 adj. No. P.02/Menhut-II/2008 on the Procedure of Licencing Equipment Used in the Exploitation of Wood Forestry Products from Timber Estates in Plantation Forests shall be amended as follows:

1. Provisions in Article 9 paragraph (4), paragraph (5) and paragraph (6) shall be combined into 1 (one) new article called Article 9A which is inserted between Article 9 and Article 10 as follows:

Article 9A

- (1) In the event of permit holders who have wood forestry product stocks originating from legal logging but the permit of their equipment has expired, applications for permits to collect, load and transport the wood shall be filed to the Head of the Provincial Office.
- (2) The Head of the Provincial Office shall issue the permits as referred to in paragraph (1) with the validity period covering 8 (eight) months at the most since the decision on the granting of the permits is issued.

Article II

This Regulation shall come into force as from the date of stipulation.
