

(b) for subsection (2) the following shall be substituted, namely:--

"(2) The Chief Administrator shall have the status and grade of, and be ex officio, Member, Board of Revenue, and his tenure and other terms and conditions of service shall be such as may be determined by the Provincial Government."

9. Amendment of section 22, Ordinance XVIII of 1980.--In the said Ordinance, in section 22,--

(a) for the words "Federal Government", occurring for the second time, the words "Provincial Government" shall be substituted; and

(b) for the colon after the word "prescribed" a full-stop shall be substituted and the proviso occurring thereafter shall be omitted.

10. Amendment of section 26, Ordinance XVIII of 1980.--In the said Ordinance, for section 26 the following shall be substituted, namely:--

"26. Power to make rules.--The Central Council may, by notification in the official Gazette, make rules for carrying out the purposes of this Ordinance:

Provided that, if the Central Council so directs, the Provincial Council may, with the approval of the Central Council, make rules in respect of administrative matters."

11. Suspension of effect of clause (2) of section 8 of the Finance Act, 1990 (VII of 1990).--Section 6 of the said Ordinance shall, until such date as the Federal Government may, by notification in the official Gazette, specify, have effect, and shall be deemed always to have had effect, as if clause (2) of section 8 of the Finance Act, 1990 (VII of 1990), had not come into force.

12. Repeal.--The Zakat and Ushr (Amendment) Ordinance, 1991 (III of 1991) is hereby repealed.
